Review:

After inspection of the furnace and evaporator coil it is my professional opinion that the hvac system needs to be replaced do to a heavy amount of soot and smoke damage from the fire. The system is beyond being able to be cleaned. Heavy amount of soot build up in blower compartment, blower motor, and blower wheel. Heavy amount of soot build up in evaporator coil and housing.

I also recommend replacing the ductwork rather than trying to have it cleaned. The smoke and soot were pulled back to the furnace through the ductwork. There is no guarantee that cleaning the ducts will get rid of the smoke smell, only replacing.

Proposal to replace furnace, air conditioner, and duct work.

4. Install new RUUD ENDEAVOR 2 ton 13.4 SEER2 condenser on new poly pad.
5. Install new line set.
6. Install new Honeywell media cleaner.
7. Install all supply and return air duct work.
8. Install flue piping in pvc pipe and fittings and terminate outdoors.
9. Gas piping, condensate drain piping, and electrical work as needed.
10. New T701 ProStat digital thermostat and stat wire.
11. Add R-410A refrigerant to system as needed.

12. Complete system start-up.
