1. Eliminate plumbing for 1st floor powder room.
2. Locate and tie into underground sanitary sewer for addition of basement bathroom.
3. Rough in DWV in sch 40 pvc pipe and fittings for basement bathroom to include: shower, toilet, sink.
4. Remove existing cast iron stack.
5. Relocate stack in sch 40 pvc pipe and fittings to accommodate kitchen remodel.
6. Connect new stack to existing 2nd floor bathroom.
7. Rough in hot and cold water lines in Type A pex pipe and fittings for basement bathroom.
8. Rough in shower control valve for basement bathroom (owner supplied).
9. Patch concrete floor in basement.
