3. Install RUUD 2 ton R454B cased evaporator coil.
4. Install refrigerant line set.
5. Install condensate drain piping.
6. Install 30 amp electrical disconnect and whip.
7. Install flue piping in sch 40 pvc pipe and fittings and terminate to outdoors.
8. Install supply air duct work.
9. Install return air duct work.
10. Supply and install all registers and grilles.
11. Install gas piping for furnace.
12. Install 18-6 stat wire and ProStat T701 digital thermostat.
