4. Rough-in above ground DWV in sch 40 pvc pipe and fittings.
5. Rough-in hot and cold water piping in Type A Pex pipe and fittings.
6. Rough-in all shower and tub controls (valves not included).
7. Install gas piping in sch 40 black iron pipe and fittings for all gas appliances.
8. Set tubs in mortar bed.
9. Hot water tank installation with expansion tank (tank not included).
10. Install 2 frost proof hose bibs.
11. Install all plumbing fixtures.
12. Make all final plumbing connections.
