1. Obtain plumbing permit.
2. Excavate and backfill for underground plumbing (spoils to remain on site).
3. Rough-in underground DWV in sch 40 pvc pipe and fittings.
4. Rough-in underground DWV for basement bathroom and possible wet bar.
5. Rough-in above ground DWV in sch 40 pvc pipe and fittings.
6. Rough-in hot and cold water piping in Type A Pex pipe and fittings.
7. Rough-in all shower and tub controls (valves not included).
8. Install gas piping in sch 40 black iron pipe and fittings for all gas appliances.
9. Set tubs and shower pans in mortar bed.
10. Hot water tank installation with expansion tank (tank not included).
11. Install 2 frost proof hose bibs.
12. Install water meter setup with PRV.
13. Install sump pump and discharge piping with check valve.
14. Install all plumbing fixtures.
15. Make all final plumbing connections.
