2. Remove and discard existing furnace and A/C system.
3. Install new RUUD Endeavor 95% high efficiency constant torque single stage gas furnace.
4. Install new RUUD 2.5 ton 13.4 SEER2 R-454B A/C condenser.
5. Install new RUUD 3 ton R-454B cased evaporator coil.
6. Install new 3" poly condenser pad.
7. Install new line set.
8. Install new electrical disconnect and whip.
9. Install new plenum and take-offs.
10. Install flue piping in sch 40 pvc pipe and fittings and terminate to outdoors.
11. Install new filter rack.
12. Re-work ductwork as needed.
13. Install condensate drain piping with EZ Clean P-Trap.
14. Electrical work as needed.
15. Gas piping as needed.
16. Install new ProStat T-705 digital programmable thermostat.
17. Add R-454B refrigerant as needed.
18. Complete system start-up.
