6. Install electrical wiring from inverter to cascade head only.
7. Install roof flashing for line set.
8. Install condensate drain piping.
9. Pressure and leak test system.
10. Vacuum system to appropriate micron range.
11. Complete system start-up.

NOTE: Electrical service for unit will need to be installed by an electrician.

NOTE: Batt insulation should be installed above drop ceiling.
