3. Install new RUUD RA1430J1NA 2.5 ton 14 SEER R410A air conditioner.
4. Install new RUUD RCF-3617 STAMCA 2.5-3.0 ton 17" wide aluminum cased coil.
5. Install new line set, pad, disconnect, and whip.
6. Install flue piping in SCH 40 PVC pipe to outdoors and terminate with horizontal flat vent termination kit.
7. Install gas piping and condensate drain piping.
8. Electrical work as needed.
9. Install new ProStat t705 digital programmable thermostat.
10. Complete system start up.
