5. Supply and install wood backing and grab bars in shower.
6. Supply and install new shower curtain rod.
7. Supply and install new Delta Cassidy Pressure Balanced Shower System with Shower Head, Shower Arm, Hand Shower, Slide Bar, Hose, Valve Trim and MultiChoice Rough-in Valve - Chrome Finish.
8. Supply and install new Gerber Viper 17" elongated toilet with 3" flush valve and Bemis wood seat - white.
9. Supply and install new 80CFM exhaust fan/light combo.
10. Supply and patch drywall as needed.
11. Supply and install new Moen Banbury pullout spray kitchen faucet - white.
12. Remove all debris from job site.
