6. Complete system start-up.

2. Install new RUUD 70k btu 95% 1 stage high efficiency gas furnace.
3. Install new RUUD 2.5 ton 13.4 SEER a/c condenser with new pad.
4. Install new RUUD 2.5-3.0 ton cased evaporator coil.
5. Install new line set, disconnect, and whip.
6. Install new digital programmable thermostat.
7. Rework gas, flue, and condensate drain piping as needed.
8. Electrical work as needed.
9. Install new digital programmable thermostat.
10. Complete system start-up.
