3. Install new RUUD ENDEAVOR 4.0 ton 13.4 SEER2 1-stage a/c condensor with new 3" poly pad.
4. Install new RUUD ENDEAVOR 4.0 ton medium efficiency cased coil.
5. Relocate condensor to side of house.
6. Install new refrigerant line set.

7. Install new flue piping in sch 40 pvc pipe and terminate to outdoors.
8. Install condensate drain piping with EZ CLEAN p-trap.
9. Install new 50 amp fused disconnect with new whip.
10. New power supply from panel to new condensor location.
11. Electrical work as needed.
12. Gas piping as needed.
13. Install new ProStat T705 digital programmable thermostat.
14. Install new Honeywell media cleaner (free of charge) with install.
15. Sheet metal work as needed.
16. Complete system start-up.

6. Install new refrigerant line set.

6. Install condensate drain piping.

9. Install Navien Peak Flow S filtration canister.
10. Install Navien NaviCirc crossover valve for external hot water recirculation.
11. Complete system start-up.
