2. Install RUUD ENDEAVOR 3.5 TON 13.4 SEER2 AC CONDENSOR.
3. Install RUUD ENDEAVOR 4 TON CASED EVAPORATOR COIL.
4. Install all supply and return air ductwork.
5. Install all underground duct work in BLACK MAX pipe and fittings.
6. Insulate all underground ductwork.
7. Bed and cover pipe in #57 stone.
8. Install line set and pad.
9. Install flue piping in sch 40 pvc pipe and fittings.
10. Install condensate drain pipe.
11. Install media air cleaner.
12. Install Wi-Fi digital programmable 2 stage thermostat.
13. Install 8-18 stat wire.
14. Add refrigerant to system as needed.

15. Complete system start-up.

SECOND FLOOR:

1. Install RUUD ENDEAVOR 96% 2 STAGE CONSTANT CFM HIGH EFFICIENCY GAS FURNACE.
2. Install RUUD ENDEAVOR 3.5 TON 13.4 SEER2 AC CONDENSOR.
3. Install RUUD ENDEAVOR 4 TON CASED EVAPORATOR COIL.
4. Install furnace in emergency drain pan with safety switches.
5. Install emergency drain for pan.
6. Install all supply and return air ductwork.
7. Insulate all ductwork in unconditioned space.
8. Install line set and pad.
9. Install flue piping in sch 40 pvc pipe and fittings.
10. Install condensate drain pipe.
11. Install condensate drain pipe.
12. Install media air cleaner.
13. Install Wi-Fi digital programmable 2 stage thermostat.
14. Install 8-18 stat wire.
15. Add refrigerant to system as needed.
16. Complete system start-up.
