2. Install underground DWV in sch 40 PVC pipe and fittings.
3. Install 1" water line in Type A pex underground to barn location for future use.
4. Continue 4" sanitary to barn location for future use.
5. Backfill.
6. Above ground DWV in sch 40 PVC pipe and fittings.
7. Tie into main water line inside of house and run through soffit for addition.
8. Hot and cold water supplies in Type A pex and fittings.
9. Install AO Smith 50 gallon electric hot water tank with expansion tank.
10. Finish work to include installing all plumbing fixtures and making final plumbing connections.
