1. Remove and discard existing furnace and a/c system.
2. Reclaim old refrigerant per EPA guidelines.
3. Install new RUUD ENDEAVOR R95 112k BTU 95% high efficiency single-stage constant cfm gas furnace.
4. Install new RUUD ENDEAVOR R454B 5 ton cased evaporator coil.
5. Install new RUUD ENDEAVOR R454B 5 ton 13.4 SEER2 A/C condenser.
6. Flush and clean line sets of old refrigerant.
7. Install EZ Clean ptrap and new condensate drain piping.
8. Install new electrical disconnect and whip.
9. Install new poly condenser pad.
10. Electrical work as needed.
11. Rework flue piping as needed.
12. Gas piping as needed.
13. Sheet metal work as needed.

14. Add R-454B refrigerant as needed.
