**Scope Of Work:**

RTU #1

Upon inspection of unit, two separate refrigerant leaks were found on circuit 1 and circuit 2.

- Primary leak coming from circuit 1 on the evaporator coil.
- Secondary leak found on circuit 2 from the service valve core.

**Recommended repairs:**

1. Recover refrigerant from both circuit 1 and circuit 2.
2. Repair evaporator coil with copper braze rod.
3. Replace 4 service valve cores.
4. Replace both filter dryers.
5. High pressure nitrogen test.
6. Vacuum system down to appropriate micron level.
7. Fill system with new R-410A refrigerant (16.15 lbs per circuit).
