1. Obtain plumbing permit.
2. Demo existing plumbing as needed.
3. Remove cast iron drain stack.
4. New drain stack from basement to 2nd floor bathroom in 3" sch 40 pvc pipe.
5. Rough in DWV for toilet, lav, shower, and tub in sch 40 pvc pipe and fittings.
6. New 3/4" water supplies in Type A pex pipe and fittings from basement to 2nd floor bathroom with new shutoff valves.
7. Rough in water lines for toilet, lav, shower, and tub.
8. Provide and install rough-in valves with service stops for shower and tub filler (Delta Multi-Choice).
9. Install shower pan.
10. Install free standing tub.
11. Install all plumbing fixtures and make final plumbing connections.
