8. Install two Diversitech ClearVue Mini-Split condensate pumps.
9. Install condensate discharge piping to floor drain.
10. Pressure test system with nitrogen.
11. Vacuum system to appropriate micron level.
12. Add R-410A refrigerant as needed.
13. Complete system start-up.
