3. Above ground DWV in sch 40 pvc pipe and fittings.
4. Water lines in Type A Pex pipe and fittings.
5. Rough-in tub/shower controls.
6. Install hot water tank.
7. Install 3 frost proof hose bibs.
8. Install gas piping for all gas appliances.
9. Install all plumbing fixtures.
10. Make all final plumbing connections.

NOTE: Price does NOT include the cost of plumbing fixtures.

NOTE: Price does not include the cost of tub/shower rough-in controls.

NOTE: Price does not include custom rough-in for master shower.

NOTE: Price does not include cost of water heater.

7. Install condensate drain piping.
8. Install media air cleaner.
9. Install humidifier.
10. Install Wi-Fi digital programmable thermostat.
11. Install 18-8 stat wire.
12. Add refrigerant to system as needed.
13. Complete system start-up.
