1. Remove and discard existing furnace.
2. Install RUUD Endeavor R95 84k btu 95% constant torque single stage gas furnace.
3. Install RUUD 2.0 ton 13.4 SEER2 R454B a/c condenser on 3" poly pad.
4. Install RUUD 3.0 ton cased evaporator coil.
5. Install new ProStat T705 digital programmable thermostat.
6. Install flue piping.
7. Install condensate drain piping with EZ Clean ptrap.
8. Gas piping as needed.
9. Electrical work as needed.
10. Sheet metal work as needed.
11. Install disconnect and whip for a/c condenser.
12. Add R454B refrigerant as needed.
13. Complete system start-up.

NOTE: This proposal does not include electrical wiring from panel to outdoor condenser (electrician will be needed).
