2. Remove and discard existing a/c system and recover refrigerant per EPA guidelines.
3. Install new RUUD Endeavor 95% high efficiency constant torque gas furnace.
4. Install new RUUD Endeavor 2.0 ton R-454B cased evaporator coil.
5. Install new RUUD Endeavor 2.0 ton 13.4 SEER2 R-454B a/c condenser on new poly pad.
6. Install right horizontal conversion kit.
7. Install Goliath emergency drain pan.
8. Install flue piping in sch 40 pvc pipe and fittings and terminate to outdoors.
9. Install new condensate drain piping with EZ CLEAN p-trap.
10. Install new refrigerant line set.
11. Install new 30amp fused disconnect and whip for condenser.
12. Install new ProStat T-705 digital programmable thermostat.
13. Electrical work as needed.
14. Gas piping as needed.
15. Sheet metal work as needed.
16. Add R-454B refrigerant to system as needed.

17. Complete system start-up.
