3. Remove refrigerant per EPA guidelines.
4. Install new Seresco Unit Replacement to include:
 - 7-Ton Compressor Dehumidifier
 - 208/3Ph
 - R454B Refrigerant
 - Pool Water Heater, Non-Vented
 - Indoor Applications
 - Vertical-Sigle Wall-Standard
 - Command Center Unit Controls
 - Fused Disconnect
 - Horizontal End Supply

- Merv 13 Filters
- OA Inlet Motorized Damper & Filter
- Unit Mounted Electric Heater
- Air-Cooled A/C - 208V/3Ph
- Connect all supply and return air duct work
- Re-insulate ductwork as needed
- New refrigerant line set
- Electrical work as needed
- Condensate drain piping
- Hot water coil piping for pool heater
- Add R-454B refrigerant as needed
- Complete system start-up with Seresco Technician

Gas & Flue Piping:

1. Remove existing gas piping and repipe in black iron pipe.
2. Pressure and leak test all newly installed gas piping.
3. Install new pressure regulator for gas fired pool heater.
4. Install new B-Vent flue piping for pool heater and terminate to outdoors.
