-Proposal to complete plumbing scope of work for 2nd floor bathroom remodel. -Price does not include cost of permit fees.
-Price does not include cost of plumbing fixtures. -Price includes all labor and material.

Scope Of Work:

1. Demo existing plumbing as needed, to include cast iron stack from basement to attic space. 2. Remove existing cast iron tub and save on sight for reinstall. 3. Rough in all new DWV in sch 40 PVC pipe for toilet, tub/shower, and lav. 4. New drain stack in sch 40 PVC from basement to 2nd floor bathroom/new stack to include replumbing toilet drain for 1st floor powder room bathroom. 5. New hot and cold water lines in pex pipe from basement to 2nd floor bathroom with new shutoff valves. 6. Cap off and eliminate radiator supply and return lines in 2nd floor bathroom. 7. Install all plumbing fixtures and make final plumbing connections for 2nd floor bathroom. **ADDITIONAL WORK:** 1.Clean up water lines and new shutoff valves under powder room bathroom in basement. 2.Check water pressure and PRV. 3.Install expansion tank on cold water. 4.Install air hammers on hot and cold water supplies by washing machine.
