1. Disassemble and remove existing furnace and air conditioner.
2. Install new RUUD R801CA-075-4 80% BTU single stage gas furnace.
3. Install new RUUD RA1330AJ1NA 2.5 ton 13 SEER 410A air conditioner.
4. Install new RUUD RCF-3617 STAMCA 2.5-3.0 ton 17" aluminum cased coil.
5. Sheet metal work as needed.
6. Flush existing line sets with cleaner and reuse existing line sets.
7. Install gas, flue, and condensate drain piping.
8. Make all electrical connections.
9. New disconnect whip, bullet fuses, and condenser pad.
10. Install new ProStat T705 digital programmable thermostat.
11. Add additional R410A refrigerant to system as needed.
12. Complete system start up.
