4. Remove all existing underground cast iron drain pipe.
5. Install new sanitary drain pipe in sch 40 PVC pipe/tie into existing sanitary sewer in basement with new clean-out tee.
6. New above ground DWV plumbing for 1st floor half bathroom.
7. Connect new PVC drain pipe to copper stack serving 2nd floor bathrooms.
8. Backfill with gravel.
9. Camera sanitary main to street/snake if needed.
10. Install plumbing fixtures in 1st floor half bathroom once bathroom is completed.
