Scope Of Work:

1. Completed heat loss calculation for proper sizing of equipment.
2. Install RUUD RH1T3617S 3.0 ton constant torque 1 stage aluminum air handler in attic space.
3. Install RUUD Endeavor RA13NZ30 2.5 ton 13.4 SEER 1 stage AC condenser with wall mounting bracket and pad.
4. Install refrigerant line set from air handler to outdoor condenser.
5. Install and insulate all supply and return air ductwork for first floor to include cutting holes in ceiling.
6. Install 2- 8" Honeywell True Zone damper controls with Honeywell Zone control board.
7. Install 10" Honeywell automatic by-pass damper on cold air return.
8. Install 2 ProStat T701 non programmable thermostats.
9. Run new 6 wire thermostat wire.
10. Install Honeywell media air cleaner.
11. Install emergency drain pan with wet safety switch for air handler.
12. Install condensate drain piping to outside with safety overflow switch.
13. Install all supply and return air grille's.
14. Install 30 amp fused disconnect and whip for outdoor condenser.
15. Add R-410A refrigerant as needed.

16. Complete system start up.
