3. Install RUUD ENDEAVOR RA13NZ18 1.5 ton 13.4 SEER 1 stage a/c condensor.
4. Install Perfect Platform Media Air Cleaner Platform.
5. Install all supply and return air ducting for addition.
6. Insulate all ductwork.
7. Flue piping installed in PVC SCH 40 pipe with flat concentric termination kit.
8. Install condensor pad, line set, disconnect and whip.
9. Condensate drain piping.
10. Install ProStat digital programmable thermostat and wiring.
11. Install dryer vent and terminate to outdoors.
12. Install range hood vent pipe and terminate to outdoors.
13. Install Modine Hot Dawg MODHD045 45k btu unit heater for garage. Side wall vent.

NOTE: NO WIRING INCLUDED EXCEPT FOR MOUNTING OF A/C DISCONNECT AND WHIP.
