1. Layout & Design of HVAC systems.
2. Permit & Inspections.
3. Install two 95% high efficiency single stage gas furnaces (70k btu and 50k btu).
4. Install two 13.4 SEER A/C condensers and evaporator coils.
5. Install line sets, pads, and disconnects.
6. Install flue piping in sch 40 PVC pipe to outdoors.
7. Install condensate drain piping.
8. Install all supply and return air ductwork for both systems.
9. Thermostat wiring and digital programmable thermostat installation.
10. Install exhaust fan termination pipe to outdoors for two bathrooms.
11. Install exhaust hood termination pipe to outdoors for two range hoods.
12. Add additional refrigerant as need to cooling systems.
13. Complete system start up.

NOTE: Media air cleaners and humidifiers can be installed at an additional cost.

NOTE: No gas piping to furnaces is included in this price.
