1. Contact OUPS to properly mark underground utilities before excavation.
2. Pull necessary permit.
3. Excavate around curb stop for access to water shutoff connection and for directional boring machine.
4. Directional bore from curb stop to foundation wall.
5. Install new 1" copper water line in Type K copper.
6. Make necessary connections at curb stop and inside of house for new water line.
7. Re-pipe water line inside of house as needed and install new 1" shutoff valve.
8. Backfill excavated areas as needed.
