OPTION 1: Replace bad section of sanitary sewer and add clean-out.

L&A Plumbing will contact 811 before starting project to locate and mark any underground utilities.

1. Excavate with excavator to expose broken section of sanitary sewer (sewer depth is estimated at 10'-11' deep).
2. Replace broken section of clay sewer pipe in sch 40 PVC and install clean-out tee.
3. Bed pipe in stone and backfill to grade.
4. Dirt will be left piled over trench for settling.
5. Remaining soils to be removed from site.
6. Obtain permit.

EXTRA NOT INCLUDED IN PRICE: Install Back Water valve on sanitary sewer outside of house (Cost: \$870.00).

OPTION 2: Replace entire length of sanitary sewer from front of house to test tee - roughly 30' of sewer line.

L&A Plumbing will contact 811 before starting project to locate and mark any underground utilities.

1. Excavate sewer trench with machine to expose existing clay sewer and remove clay sewer.
2. Install new sanitary sewer from foundation wall to test tee in sdr 35 sewer main pipe (sewer depth is estimated at 10'-11' deep).
3. Install clean-out at front of house and replace test tee with new clean-out tee in yard by sidewalk.
4. Bed pipe in gravel and backfill to grade.
5. Dirt will be left piled over trench for settling.
6. Remaining soils to be removed from site.
7. Obtain permit.

EXTRA NOT INCLUDED IN PRICE: Install Back Water valve on sanitary sewer outside of house (Cost: \$870.00).
