4. Install RUUD 4 ton cased evaporator coil.
5. Install new line set.
6. Install new electrical disconnect and whip.
7. Install flue piping in sch 40 pvc and terminate to outdoors with flat concentric kit.
8. Install condensate drain piping.
9. Gas piping as needed.
10. Electrical work as needed.
11. Sheet metal work as needed.
12. Install new ProStat digital programmable thermostat.
13. Install new AprilAire 700M whole house humidifier.
14. Add R-410A refrigerant to system as needed.
15. Complete system start-up.

10. Electrical work as needed.
11. Sheet me work as needed.
12. Install new ProStat digital programmable thermostat.
13. Install new AprilAire 700M whole house humidifier.
14. Add R-410A refrigerant to system as needed.
