1. Remove and discard existing HVAC equipment.
2. Install new RUUD ENDEAVOR 98k btu 95% high efficiency 1 stage constant cfm gas furnace.
3. Install new RUUD ENDEAVOR 3 ton cased evaporator coil.
4. Install new RUUD ENDEAVOR 2.5 ton 13.4 SEER2 condenser with 3" poly pad (existing wall bracket to stay).
5. Install new line set from indoor unit to outdoor unit.
6. Install new slim duct line set cover on exterior of building.
7. Install new 30 amp disconnect and whip.
8. Install new flue piping in sch 40 PVC and terminate to outdoors with flat termination kit.
9. Condensate drain piping as needed.
10. Gas piping as needed.
11. Electrical work as needed.
12. Install new ProStat digital programmable thermostat.
13. Rental of 24' material lift.
14. Add R-410A refrigerant as needed.
15. Complete system start-up.
