1. Reclaim R-410A refrigerant back to compressor in outdoor unit.
2. Remove and discard existing furnace and indoor evaporator coil.
3. Install new WeatherKing 100k btu 80 % gas furnace.
4. Install new WeatherKing 2.5-3.0 ton cased evaporator coil.
5. Reconnect line sets to indoor coil.
6. Refill refrigerant charge and check system charge.
7. Install new flue piping to chimney.
8. Gas piping as needed.
9. Electrical work as needed.
10. Sheet metal work as needed.
11. Install new ProStat digital non-programmable thermostat.
12. Complete system start-up.

OPTION 2: 95% high efficiency gas furnace.

1. Reclaim R-410A refrigerant back to compressor in outdoor unit.
2. Remove and discard existing furnace and indoor evaporator coil.
3. Install new WeatherKing 85k btu 95% high efficiency gas furnace.
4. Install new WeatherKing 2.5-3.0 ton cased evaporator coil.
5. Reconnect line sets to indoor coil.
6. Refill refrigerant charge and check system charge.
7. Install new flue piping in sch 40 pvc pipe and terminate to outdoors.
8. Gas piping as needed.
9. Electrical work as needed.
10. Sheet metal work as needed.
11. Install new ProStat digital non-programmable thermostat.
12. Complete system start-up.
