7. Seal all duct work with duct seal.
8. Install 18-6 stat wire and ProStat digital programmable thermostat.
9. Install condensate drain piping with EZ-Clean ptrap.
10. Install flue piping in sch 40 pvc pipe and terminate to outdoors with flat termination kit.
11. Electrical as needed to include disconnect and whip.
12. Complete system start-up.
13. Permit.
