3. Rough in water supplies and drain line for laundry room renovation.
4. Rough in water supplies and drain lines for 1st floor half bathroom renovation.
5. Rough in water supplies and drain line for garage utility sink (L&A to supply sink and faucet).
6. Rework existing plumbing as needed/cap off abandoned plumbing as needed.
7. Install water filtration system for kitchen sink (owner to specify filtration system).
8. Install ice maker line with shutoff valve.
9. Make all final plumbing connections and set fixtures.

HVAC SCOPE:

1. Rework cold air return.
2. Rework supply air duct(s) as needed.

NOTE: Price does not include cost of plumbing fixtures except for utility sink and faucet.

NOTE: Price does not include cost of permit or fees.
