4. Install 1" ball valve inside of house.
5. Pipe meter set.
6. Install 3/4" pressure reducing valve.
7. Tie into existing water line inside of house from meter with Type A PEX pipe.
8. Install 2 gallon expansion tank.
9. Bed pipe in sand and backfill to grade.
10. Permit and inspection.

NOTE: This price does not include the cost of permit.
