**Scope Of Work:**

**1ST FLOOR HVAC:**

1. Open item.

**2nd FLOOR HVAC:**

1. Remove and discard 2nd floor HVAC system.
2. New HVAC system to go in attic space.
3. Install RUUD ENDEAVOR high efficiency R95 56k btu constant torque gas furnace.
4. Install RUUD ENDEAVOR 3 ton cased evaporator coil.
5. Install RUUD ENDEAVOR 3 ton R-410A 13.4 SEER2 A/C condenser.
6. Install all supply and return ductwork and insulate.
7. Install 6" make up air with automatic damper.
8. Unit will be installed with emergency drain pan with wet switch and condensate safety switch.
9. Install line set, disconnect, whip, ac pad, and line set cover on exterior.
10. Condensate and emergency drain line piped to basement drain.

11. Concentric kit for flue piping in sch 40 pvc through roof.
12. 18-6 stat wire with ProStat digital programmable thermostat.
13. Gas line from basement to unit in attic.
14. Misc electrical work.
15. Add R-410A refrigerant as needed.
16. Complete system start-up.

NOTE: Electrician to provide power to unit in attic and to outdoor condenser.

**NURSERY HVAC:**

1. Install LG LS180HVS5 high efficiency single zone 1.5 ton mini split.
2. Install line set.
3. Wall bracket for condenser.
4. Electrical wiring from condenser to indoor head (electrician to provide power and service disconnect).
5. Line set cover on exterior.
6. Complete system start-up.

COST: \$4,900.00

**DRYER AND EXHAUST VENTS:**

1. Install 4 bathroom exhaust vents and terminate to outdoors (price does not include fans).
2. Install dryer exhaust vent.

COST: \$1,000.00

**PLUMBING:**

1. Rough DWV in sch 40 pvc for 1st floor restrooms.
2. Rough DVW in sch 40 pvc for 2nd floor restrooms.
3. Rough DWV in sch 40 pvc for nursery restroom and kitchen sink.
4. Rough DWV in sch 40 pvc for basement restroom.
5. Rough DWV in sch 40 pvc for basement laundry.
6. Rough DWV in sch 40 pvc for kitchen.
7. Install 1" Backflow Device on water main.
8. Hot and Cold water piping to all plumbing fixtures in Type A pex and fittings.
9. Gas piping for kitchen.
10. Install all plumbing fixtures and make final plumbing connections (owner to supply plumbing fixtures).

NOTE: This price does not include the cost of demo of existing plumbing system.
