2. Remove humidifier and patch ductwork in order to create more space for water filtration system.
3. Remove not in service electrical and phone wire boxes.
4. Rework hot and cold water supply piping for relocation of filtration system and for tankless water heater.
5. Install Navien NPE-240A tankless water heater.
6. Install isolation valve kit.
7. Install expansion tank.
8. Install external recirculation piping at unit.
9. Install Navien Peak Flow-S filtration canister.
10. Install Navien NaviCirc crossover valve for hot water recirculation.
11. New exhaust and intake piping in sch 40 pvc to terminate to outdoors with concentric termination.
12. Install condensate drain piping.
13. Install gas piping.
14. Electrical work as needed.
15. Complete system start-up.
