7. Install low water cutoff.
8. Install new ProStat digital thermostat.
9. Install 6" flue liner in chimney for boiler and hot water tank per order of the City of Lakewood.
10. Gas piping as needed.
11. Electrical work as needed.
12. Complete system start-up.
