4. Connect to existing clay drain pipe and install new p-trap in sch 40 PVC.
5. Install new Sioux Chief SquareMax™ Floor Sink with open quarter strainer.
6. Backfill and cement floor.
7. Re-work laundry tub drain as needed.
8. Remove and discard any excess debris.
