4. Remove existing clay tile sewer.
5. Install new sewer line in SDR PVC sewer main pipe and fittings.
6. Install new sanitary test tee.
7. Install new sanitary clean-out at front of house.
8. Back fill pipe in stone.
9. Back fill trench with dirt.

All landscaping required for completion of the job shall be the customer's responsibility.
3.
