3. Install new ice maker supply for refrigerator.
4. Install new frost proof silcock.

JOB 2:

1. Install kitchen faucet, garbage disposal, drain connection with Oatey AAV.
2. Install dishwasher.

NOTE: OWNER TO PROVIDE FAUCET, DISPOSAL, AND DISHWASHER.

JOB 3:

1. Re pipe sump pump discharge piping and install check valve.

COST: \$395.00

JOB 4:

1. Re pipe water supplies for laundry set up in copper pipe and fittings.
2. Install new ball valves for laundry supply.
3. Install new washing machine valve.
4. New top feed laundry tray faucet.
5. Re pipe washing machine drain and utility tub drain and make proper connection below slab.

JOB 5:

1. Replace gas shut off valve for hot water tank.
2. Re pipe 3/4" hot and cold supplies to hot water tank with new 3/4" shut off valve on cold feed.
3. Remove out of use saddle valve.

1. Replace 8 - 1/2" ball valves.
2. Replace 1 - 3/4" ball valve.
